

Terms and Conditions for Access to this Site

The *World Forum of Catastrophe Programmes* is a group assembling various natural catastrophes insurance systems in the world that feature public intervention. It is a means by which the systems that freely wish to join the Forum (hereinafter WF participants) exchange their knowledge, information and experience. The possibility that this kind of information would be useful for other institutions, organizations and the general public with an interest in natural catastrophes management, especially in the insurance coverage of these perils, led the WF participants to create this website. The WF participants entrusted the Consorcio de Compensación de Seguros (Spain) with the development and the management of the site.

Thus, this website is for exclusively informative purposes and absolutely free of any profit-making interest or commercial objective. The intention of this website is to provide users with information on natural catastrophes in general and specifically on insurance cover for them, in relation to the cover schemes of the WF participants.

The content of the web-site is owned by the WF participants. Consulting it is free in both senses and users are allowed to download documents and copy pages provided that the source is mentioned together with the date of the download or copying and on the condition that the content is not altered or tampered with. Under no circumstances is authorization given for the commercialisation of any of the web-site's content by third parties, whatever the format or type of distribution.
